The proposed procurement consists of Multi-tasking Equipment (MTE) High Speed, Multi-Tasking Snow Removal Unit to include Carrier Vehicle, Snow Plow, Underbody Scraper, Rotary Broom with High Velocity Air Blast necessary in accordance with the Sponsor's specifications. Special attention shall be given to the Buy American requirement of this contract. A 5% bid bond shall be submitted with the bid.
