NOTICE OF AVAILABILITY OF A DRAFT WRITTEN RE-EVALUATION ENVIRONMENTAL ASSESSMENT AND NOTICE OF A PUBLIC HEARING FOR A PROPOSED RUNWAY EXTENSION PROJECT

Cherry Capital Airport (TVC) Traverse City, MI

The Northwestern Regional Airport Commission is holding a public hearing on the Draft Written Re-evaluation Environmental Assessment for the following development at the Cherry Capital Airport:

- Extend Runway 10 by 115 Feet (115' x 150')
- Rehabilitate existing Runway 10/28 (6,900' x 150')
- Install Medium Intensity Approach Lighting System with Runway Alignment Indicator (MALSR) lights on Runway 10
- Relocate Visual Approach Slope Indicator (VASI) lights on Runway 10 or replace with Precision Approach Path Indicator (PAPI) lights
- Rehabilitate Runway 10/28 lighting circuit
- Relocate and pave perimeter road around Runway 10 extension (on Airport property)
- Extend Taxiway D to match Runway 10 extension
- Extend Taxiway G to match Runway 10 extension
- Obstruction clearing in Runway 10 approach
- Property easement / acquisition in Runway 10 approach for obstruction clearing
- Construct fencing in Runway 10 approach for visual shielding

ALL INTERESTED PERSONS are notified of the availability of the Draft Written Re-evaluation Environmental Assessment evaluating the potential effects of the proposed improvements. ALL INTERESTED PERSONS are further advised of a public hearing being held by the Northwestern Regional Airport Commission. The purpose of the public hearing will be to consider the social, economic and environmental effects of the proposed improvements and whether the improvements are in the public interest and consistent with the goals and objectives of area planning. The public hearing is scheduled for:

- Tuesday, March 14, 2017 from 5:00 PM to 8:00 PM at the Cherry Capital Airport, 727 Fly Don't Drive, Traverse City, Michigan 49686 (meeting will be held in the administration office located on the second floor)

The public hearing will be an open house format with no formal presentation given. Members from the project team will be available to answer questions on an individual basis. Interested participants may attend the meeting anytime between the listed hours. A court reporter will be available for those persons who would like to make a statement regarding the project and have it included in the official transcript of the public hearing. Participants will also have the opportunity to fill out comment forms and leave them at the meeting in designated comment boxes.
