# TVC 2024 CFME Addendum 1 - June 26, 2024 Notice to Prospective Bidders

In accordance with Article 7 of the Bid Documents and Section 14 of the Purchase Order, this Addendum is hereby issued as part of the Contract Documents.

- 1) Questions can be posted until 7 Calendar days before bids are due or July 5, 2024.
- 2) The NRAA is requesting the winter use of the vehicle by October. The bid form allows Vendors to insert the date actual delivery can be provided. The NRAA is able to evaluate bids based upon schedule and LDs. For example, a delivery date of November 15 versus December 15: 30 days beyond the November 15 bid would add \$500\day in LD by the 30 day difference which would account for an additional \$15,000 when considering the Dember 15 bid.
- 3) Insurance: The only insurance required on page 12 of the bid docs (PO) is general liability and automotive which is needed for onsite training personnel and warranty work.
- 4) The CFME is required to have a 1-year warranty. Additional bid line items have been added for optional extended warranty costs that will not be considered in the award process. See attached revised Bid Form.
- 5) The bid form assumes the carrier vehicle has standard warranties beyond 1-year. The bid form has been modified to clarify the standard vs extended warranty costs.
- 6) For information purposes only (NOT a bid requirement) the NRAA uses the following local vendor to outfit airport fleet vehicles with radios and lighting:
  - a. Grand Traverse Mobile. 231-947-9851. 1670 Barlow St. Ste. 1 Traver City, Mi 49686. (Harold)
- 7) Support statement: In summary, the FAA requires NRAA to use the CFME for 10 years before allowing us to purchase a new one. As such, the NRAA wants the means by which to maintain the vehicle and CFME over the next 10 years. The NRAA will work with the successful low bidder over the next 10 years to verify replacement parts or manufacturer approved replacement systems can be made in order to obtain the full useful life of the vehicle. In the event that a manufacture cannot provide a replacement part or of replacement system, the NRAA would like the necessary information to machine\fabricate those systems for the useful life of the vehicle.
- 8) The NRAA has a stock of 1551 tires, hence that stated preference. Bidders are to provide manufacturer tires consistent with the product certification.
- 9) A separate keyboard is not required.
- A separate printer is not required provided the computer\tablet system must be able to run MS365 Outlook in order to allow the computer to email logs compatible with NRAA email accounts and cybersecurity.

- Additional paint colors for various manufacturers were requested. Based upon online information, the NRAA believes the following paint codes to be comparable between the various manufacturers.
  - a. Ford EA hot pepper tricoat
  - b. Chevy/GM G7C cardinal red
  - c. Ram PR4 flame red
- 12) If preferred vehicle color is not available, the bid form has been modified to allow for the supplemental bid item to have a dealer\vendor (preferably but NOT required to be local) to repaint the vehicle to the specified color.
- 13) Per page 18, Item B(1) of the bid docs the NRAA is requesting a crew cab configuration with a trim level above base providing basic features.
- 14) If not required by the manufacturer to provide a complete CFME with vehicle, a separate battery system is not required.
- 15) If not required by the manufacturer to provide a complete CFME with vehicle, a 3000W inverter is not required. HOWEVER, the NRAA will still require a 1000W inverters with plugs\ports accessible by the driver.
